TERMS AND CONDITIONS

STABLING

It is a possibility that stalls WILL SELL OUT. With this being the case, event sponsors will have priority to receive stalls, after that stalls are on a first-come-first-serve basis. Once stalls are full, a wait list will be started. There is no guarantee of available stalls. Stall rate \$325 per stall.

ALL STALLS MUST BE ORDERED ONLINE. There are no Haul-Ins allowed! Horses attending the event must have a stall. No stall refunds after October 15th. A LATE FEE OF \$25 PER STALL WILL BE APPLIED TO ALL STALL RESERVATIONS AFTER 10/15. MOVE IN BEGINS

SUNDAY, OCTOBER 19th at 10:00AM. Move out is required by Monday, October 27th | 10:00AM. **TRAINERS – YOU ARE ULTIMATELY RESPONSIBLE FOR PAYING FOR STALLS ORDERED IN YOUR GROUP! PLEASE COMMUNICATE WITH YOUR CUSTOMERS TO AVOID DUPLICATE STALL ORDERS.**

DAMAGE

Individuals will be responsible for any physical damage inflicted to the LA Equestrian Center property and will reimburse the show management for such damage as it may be charged. All owners and exhibitors shall be responsible for any damage incurred by them, their agents or employees to stalls, buildings, and other properties on the show grounds and shall be billed accordingly.

HEALTH REQUIREMENTS & CERTIFICATES

Health requirements for the State of California and the L.A. Equestrian Center will be followed. A 30-day health certificate and 12-month Coggins are required upon arrival. This includes horses that reside in the state of Nevada.

PHOTOGRAPHERS/VIDEOGRAPHERS

No outside video or photography is allowed. By way of entry into the event, exhibitors, and their respective employees, agents and family members grant permission without remuneration for the use and public distribution of their image, likeness, voice and video for the possible promotion of the event. All exhibitors will be subject to the use of photographers and videographers under the direction of show management for the benefit of show promotion. No exhibitor will be allowed the discretionary use of his or her services. All images pertaining to or in relation to the CRHA Challenge Horse Show are under the sole ownership of CRHA. All photographs taken will be posted the CRHA facebook page and may be used for free. We will also be sending free videos to exhibitors.

LIABILITY

By participating in the CRHA Challenge, all exhibitors agree to abide by the rules of the show and the governing body NRHA. In addition, exhibitors acknowledge that horses are dangerous animals and can be hazardous. By participating in the competition with this knowledge of the danger involved the exhibitor agrees to accept any and all risks of injury or death.

RULES/CHANGES

The CRHA Challenge and The CRHA, reserve the right to make additions or changes to this event at any time. Show management has the authority to enforce all rules referring to the show and may excuse any horse or exhibitor from the show prior to, during or after the judging without refunds. **SHOW MANAGEMENT RESERVES TO ITSELF THE RIGHT TO REFUSE, ACCEPT CONDITIONALLY, OR TO CANCEL ENTRIES, DISQUALIFY ANY RIDERS OR EXHIBITORS, PROHIBIT EXHIBITION OF ENTRIES AND CANCEL AWARD PRIZES, WITHOUT CLAIM OF DAMAGES.** The show management reserves the right to interpret these rules and regulations. All decisions are final. By way of making an entry, the exhibitor is assuming responsibility for knowledge of the rules and releases show management from any claims or losses. The show management reserves the right to modify or change conditions for the CRHA Challenge event at

RIGHT TO CANCEL

The show management reserves the right to cancel the event without notice at any time prior to the contest and without liability to the show management. In the event of such cancellation, entry fees or other show fees paid in advance shall be refunded. The show management reserves the right to itself to interpret all questions and conditions regarding, or arising out of, or incident to, the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by show management, its decision to be final. Every horse entered herein for competition will be under control of the show management, but the show management will in no case be responsible for any loss or damage that may occur and it shall be a condition of entry that each exhibitor shall hold the Horse Show, officials, employees, Directors, Sponsors and the South Point Event and Equestrian Center blameless for any loss or accident to horse(s), employees or equipment.

BEHAVIOR, CONDUCT AND ANIMAL WELFARE

Any action of disrespect, deceit, or fraud directed to show management, grounds crew, show representatives or judges will result in disqualification from competition and removal from the facility. No fees, entry or stall refunds will be provided. Individuals accused of unsportsmanlike conduct will be subject to the disciplinary procedures set forth by the National Reining Horse Association in Article A of the handbook and will be suspended from CRHA Events for a term determined by show management. NO ABUSE TO ANY ANIMAL WILL BE TOLERATED. Stabling and arenas will be monitored 24 hours a day. Anyone found to be abusing animals will be disqualified and reported to NRHA.

EXHIBITOR SCHOOLING GUIDELINES

Every competition class offered at this event is broadcast LIVE over the internet to the WORLD. To maintain the integrity and professional appearance of the event, all exhibitors choosing to enter COMPETITION CLASSES to school horses, MUST present these horses in show attire. Show attire is defined as; exhibitor's entry is required to present their horse with a show pad, clean tack, and the horse's tail must be down (not braided or up in a tail bag/sock). It is requested by show management that the rider wear show chaps. As per NRHA Attire Guidelines, a long sleeve shirt, western hat and boots are required. The Equipment Judge located at the back gate of the show arena will enforce this guideline.

DIVISIONS: In the case of multiple divisions running concurrently, once the draw is posted divisions may be added, but this must be done prior to the first horse of the class going in the pen. It is the exhibitor's responsibility to confirm divisions entered prior to the draw taking place. In the event of an office error, a division will be added prior to the start of the competition. It is the exhibitor's responsibility to notify the show office prior to the start of the competition if the divisions listed are incorrect or missing.

ANCILLARY: For horses of **any age** as of the start of the calendar year. See NRHA rule book for division requirements.

FUTURITY: For horses **three years of age** as of January 1st. Horses may be shown one-handed in a bridle, or two-handed in a snaffle bit or hackamore.

DERBY: For horses **four, five, six, seven, and eight years of age** as of January 1st. Horses may be shown one-handed in a bridle, or two-handed in a snaffle bit or hackamore.

STAKES: For horses **four years of age** as of January 1st. This class runs concurrently with the Derby. Horses may be shown one-handed in a bridle, or two-handed in a snaffle bit or hackamore.

Horse show retains 40% of aged event entry fees.

ENTRY CONDITIONS

PRE-ENTRY REQUIREMENTS: (Must be **received** by October 15th)

Submission of online entry form, one per horse, NRHA Competition License and Owner/Rider current NRHA Membership cards, and signed Participation Liability Release must be RECEIVED by October 15, for entry to be considered complete. A form of payment will be required to check in and receive your number at the show office.

Each horse entered in the event will be assessed a one-time Administration Fee of \$85, Media Fee \$60, Post Entry Fee of \$85 (if applicable, California Drug Fee \$14 and NRHA Drug Fee of \$35. Exhibitors who do not close out their showbill prior to their departure will be charged a one-time fee of \$15 to close out the showbill and email receipt statement. A 3.5% convenience fee will be added to all credit card charges. DO NOT MAIL ENTRIES IF THEY WILL BE RECEIVED BY SHOW MANAGEMENT AFTER OCTOBER 15th! **NO REFUNDS WILL BE PROVIDED ONCE THE CLASS DRAW HAS BEEN POSTED.**



Post entries will be accepted until 3:00pm the day BEFORE the class is to take place. An ADD Card must be filled out in the show office for all added classes prior to deadline. A SCRATCH Card must be filled out in the show office for all scratched classes. NO CHANGES WILL BE TAKEN AT THE BACK GATE.

ANCILLARY DIVISIONS

Submission of completed online entry must be **RECEIVED** by October 15th, for entry to be considered complete and avoid the \$85 late fee assessment. Event retains 50% of entry fees. NRHA payback Schedule A percentages utilized and will be based on the number of eligible entrants in each division.

SCRATCHES

If horses are scratched from the show the Admin fee will apply.

AWARDS

Exhibitors are responsible for picking up their awards at the event. Awards not picked up at the event will not be shipped.

AWARD PAYOUT CHECKS will be mailed once management receives NRHA results approval. If NRHA does not return approved results to show management within 30 days after the last day of the event, checks will be mailed out to abide by NRHA's 30 day payout rule requirement. If checks are mailed out prior to show management receiving NRHA result approval, CRHA Challenge. and CRHA will not be held liable for any prize money or awards not returned to show management by those who are disqualified by NRHA. Those who fail to return disqualified prize money within 10 days of notification will be **SUSPENDED** from participating in any further CRHA events and reported to the NRHA for disciplinary procedures. Any outstanding balances owed will be deducted from payouts. Returned checks will be charged a \$50 NSF Fee. Any remaining balances due to event will have 10 days to provide payment in full. Payments not received within the designated time may incur penalty fees.

DRAGS: The drag will be set after every ten (10) horses on paper in **ANCILLARY** classes. The drag will be set after every six (6) horses on paper in all **OTHER AGED EVENTS..** The drag **WILL NOT** be moved due to scratches.

GENERAL RIDING ARENA SAFETY PROTOCOL:

All riders must **IMMEDIATELY** exit the arena for the water truck entering. When a tractor/drag enters an arena, all riders in the arena must move to one side of the arena. Once at the side of the arena, riders must cease all motion (including walking, spinning, trotting circles, backing, etc.). Failure to comply will result in all horses being excused from the arena to complete the drag.

\$20,000 ADDED **RANCH FUEL SUPER SLIDE**

The intent of the Ranch Fuel Super Slide is to highlight the signature reining maneuver....The Slide!

GENERAL RULES:

1. The class is open to anyone.
2. The rider does not need to own the horse.
3. Riders are limited to entering two horses.

Payout is as follows:

- 1st Place-\$7,000.00
- 2nd-5th Place-\$2,000.00 each
- 6th-10th Place-\$1,000.00 each

JUDGING:

1. The maneuver is judges on the run into the arean and the sliding stop, NO BACK UP.
2. There are four (4) judges and all scores count.
3. The judge is evaluating the standard criteria outlined in the NRHA handbook.
 - a. Approach (Run Down)
 - b. Form & Style
 - c. Degree of Difficulty
 - d. Finesse/Willingness
 - e. Physicality
4. The judge is to score from 0-10 using 1/2 point increments with 10 being perfect.
